## EXOTICS AND REPTILIA BOARDING WAIVER

This Exotics and Reptilia Boarding Waiver ("Waiver") is entered into between the pet owner, hereinafter referred to as the "Owner," and Pawsitive Natural Pet Resort Inc., hereinafter referred to as the "Facility." This Waiver is effective from the date of acceptance and shall remain in force for the duration of the boarding period.

The Facility agrees to collect for its records all information necessary to secure health, safety and liability for any and all pet(s) being boarded at the facility, which may include but is not limited to:

## **Agreement Terms:**

### **1. Acknowledgment of Health:**

The Owner acknowledges that the exotic pet and/or reptile(s) being boarded are in good health and have received all necessary vaccinations, health records and permits, if applicable. The Owner will provide proof of verification of health if requested by the Facility.

### **2. Emergency Medical Care:**

The Owner authorizes the Facility to seek emergency veterinary care for the exotic pet and/or reptile(s) in the event of illness or injury. The Owner agrees to cover all related expenses.

### **3. Dietary Requirements:**

The Owner will provide the exotic pet(s) and/or reptile(s) specific dietary requirements and any necessary feeding instructions. The Facility will make every effort to follow these instructions but is not liable for any adverse reactions.

### **4. Liability:**

The Owner understands and accepts that exotic pet(s) and/or reptile(s) are living creatures and that the Facility will take all reasonable precautions for their safety and well-being. However, the Facility is not responsible for any injury, illness, or escape that may occur.

### **5. Release of Liability:**

The Owner releases the Facility, its owners, employees, and agents from any and all liability for injury, loss, or damage to the exotic pet(s) and/or reptile(s) while in the care of the Facility.

### **6. Payment:**

Payment for boarding services will be made as agreed upon between the Owner and the Facility. The Owner agrees to pay all fees promptly as specified.

### **7. Cancellation Policy:**

The Owner understands and agrees to the Facility's cancellation policy, which may require advance notice of any changes to the boarding reservation.

To secure your reservation, a 50% non-refundable deposit is required. In the event of cancellation, the deposit will not be refunded.

We understand that unforeseen circumstances may arise, and we encourage clients to notify us as early as possible to make alternate arrangements.

Any cancellations made within 24 hours of the scheduled booking will incur the full cost of the reservation. We appreciate your understanding and cooperation.
